Dear Karen and the Mapua Hall Society Committee,

Thank you for talking with me on Tuesday 30th November in response to the 'User Update' MDCA received from Mapua Hall on the committee's decision to enforce the requirement for all Mapua Community Hall users to present their **My Vaccine Pass**.

At the MDCA's Executive meeting held on Tuesday 23rd November, the Executive also discussed how the Traffic Light System could impact MDCA meetings moving forward, with consensus reached on the following position:

MDCA will comply with the Covid Protection Framework (Traffic Light System) in such a way that is fully inclusive of all members and residents within our community and will look to guidance from Mapua Hall and our TDC representatives to ensure we can achieve this in a compliant, safe and inclusive manner.

MDCA are aware that some in our community are anxious about navigating the changing Covid situation and this is unknown territory and worrying for many. However MDCA supports community members' continued access to community facilities and public meetings.

Our understanding of Mapua Hall's decision is you have chosen to operate using the **My Vaccine Pass** only, even though the Traffic Light System at Orange clearly allows Indoor Public Meetings / Events of up to 50 participants regardless of vaccination status provided attendees are spaced at least 1 metre apart and mask-wearing is mandatory.

We were hoping to continue to hold our Public Meetings in this manner, while fully adhering to capacity limits, scanning-in / signing in, masking and social distancing procedures. Since the turnout to our Public Meetings is generally less than 30 people, and assuming we continued to have access to the larger Main Hall, this was considered the best way forward.

However, given the Hall has now taken the decision on behalf of all Hall users to strictly enforce **My Vaccine Pass**, MDCA is seeking clarification on the processes that will be in-place at our meetings.

Specifically, can you please confirm the following:

- Vaccine Pass must be presented and identification verified (via drivers licence?) prior to entry
- Who has responsibility for enforcing and verifying My Vaccines Pass? (Hall or MDCA)
- No limits on meeting size will apply
- No social distancing is required (so can we revert to meeting in the Bill Marris Room?)
- Mask wearing will not mandatory

We look forward to your earliest response.

Public facilities guidance

COVID-19 Protection Framework guidance if you operate a public facility.

Public facilities are services at facilities provided by central or local government, that are open to all of the public for recreational, social, community or cultural activities or services, including museums, public galleries, libraries, recreation centres, swimming pools, and zoos. Membership facilities are not included. Event or gathering rules apply to any part of the facility that is hired for exclusive use.

Businesses and services must display NZ COVID tracer app QR codes, and are required to ensure that, as much as possible, record keeping is undertaken (ie all those on premises must scan QR tracer codes, or other record keeping must be used).
