I have been asked to follow up on a few things following the last MDCA meeting:

1. Whilst discussing reserves and pathways I was asked about the definition of "unformed legal roads" and whether these were the same as "paper roads" or "indicative roads"? Can you shed light on this? Unformed legal roads = paper roads, ie public road. Indicative roads are different in that they are just a planning overlay which helps guide layout of future development.
2. Followup to the Mapua Drive clay removal: The process has already been discussed but the community would like to be involved in the remedial tree planting. Richard Hilton may have put in an order for natives but it would be good if he could engage with the MDCA on the plan for remediation. I have copied Richard Hilton into this
3. During the process of excavation the southern section of Mapua Drive involved has suffered increased surface deterioration and I was asked if the developer is to be asked to remediate it? The whole section from #77 down is really in need of resurfacing and you may have plans for this? This is to be resealed this current season – will be completed before end of March (weather permitting!). Obviously there will be some traffic disruption for a day or so while sealing takes place
