Thank you to Elena	<p>Wayne spoke on behalf of the community Association and the greater Mapua area, with respect to the contribution that Elena had made over the past years. Elena has resigned her position on the executive but will still be working with the MDCA. Elena started with M DCA in 2001 and in 2011 joined the executive. Elena was chairperson from 2015 until 2018 and played a big part in ensuring that the collective views of the community were represented to the association. Elena led the idea of ensuring that views were collected from the community. It didn't matter if views were polarising but she ensured that members of the community were a voice in community planning or in other groups such as the Waterfront Park working group. The MDCA social media was set up during Elena's time on the community Association and ensured that the community had the opportunity to participate in zoom meetings from a distance or face to face. Elena was the first regular user of Maori language in association meetings in the written and in the spoken form. The development of the Hub as part of the community and the growth of the Willing Wheels initiative has shown how much Elena is involved in ensuring that each part of the community has a place to meet and that those who require transport to and from Mapua have the ability to achieve that mobility. The integration of the Willing Wheels initiative and the new bus service from Motueka to Richmond has shown the need for this transport initiative to be developed further.</p> <p>Elena intends to carry on with her development of the Hub in the village and ensuring that the transport situation meets the needs of not only Mapua but also the greater Tasman community. TDC counsellors applauded the initiatives of Elena and noted that as chairperson she was very welcoming to counsellors and had a wide understanding of a variety of concepts for the community. Mayor Tim King acknowledged that jobs became much easier when groups came to agreement and everyone was heard. This was one of the main aspects of Elenas time as chairperson. Mike acknowledged the input that Elena had had in her work with the Boat Club and its relationships with TDC</p> <p>In reply Elena acknowledged the appreciative comments that had been made and noted that over the years in her work with MDCA she had work with a large number of people on a variety of different programs. Elena wanted to acknowledge the support that she had had from TDC counsellors and to acknowledge also the assistance of Helen and her work with in MDCA.</p>

Eight months ago the developer was told to remove it but the developer says the responsibility lies with TDC. The area is extremely dangerous and wanted to know that it has been brought to the councils attention. Mayor Tim King will investigate - Fred Robertson has a concern about the restoration which is supposed to take place at Grossi Point. It appears that a large number of waratahs and concrete blocks are creating hazard. The plan initially for the restoration of Grossi Point was supposed to conclude in 2022 but nothing appears to have happened. Fred would like to organise a group to remediate the area. The response from council was that they were waiting for a response from the local Iwi and there is a meeting next week. Mike offered to meet with Fred to discuss the matter.

Disabled car-parks are to be set up opposite the medical centre. A Covid fund has been set up for groups affected by the virus outbreak and groups which are affected can apply for funding for administration. - Christine McKenzie: identified that all council meetings are now conducted by zoom on these will include topics such as the future development strategy. The annual plan is now being developed as previous assumptions which were made on are now redundant. The three waters initiative is progressing slowly. At present what is going to happen to local government under the new local government New Zealand is remaining up in the air until for the meetings are held.
