Thanks for the chat today. Please find below update for your meeting tonight.
I have confirmed with Jamie that these 3x parks will be changed to motorcycle. Originally when we were trying to get it all marked up before Xmas there was just some concerns that we were losing 3x carparks in such a busy area, but as it is strongly supported by FENZ and the Mapua Waterfront and Community Association we will proceed as requested.
I have talked to Downer about why not <u>all</u> the markings have been installed and they advised that most of the no-stopping has been installed, bar some of the areas where there were cars parked. They have been trying to get back and complete but the weather has been holding that up. Their B-type machine is also currently in the shop getting repaired, may not be back until early next week.
As soon as the machine is back up and running we will go out and finish all of this off, including the motor cycle parks.
In relation to the requested changes to the area near the Mapua Medical Centre, I will be running a proposed plan by Mike VE this week –once approved, this will then go out for consultation with affected residents/business owners.
At this stage the date for the next Council meeting when the proposed changes will go for approval is the 7 April.


