Council have been working on improving how people and goods move around the district. One area that we have been looking at improving is walking and cycling as a form of transport. Council have pulled all this work together into a walking and cycling strategy. The strategy covers all micro mobility devices designed for use on footpaths and cycleways. Council has recently released the draft Walking and Cycling Strategy for public consultation and would appreciate a submission from you on behalf of Mapua and Districts Community Association.

Due to COVID 19, normal opportunities to discuss this draft strategy face to face cannot go ahead. Instead, we would like to invite you to a specific online seminar for key stakeholders where we will summarise the strategy and provide an opportunity for you to ask questions.
