

Good morning Christeen,

I hope you are well.

I would like to let you know that the plaque has now been permanently placed in the pathing our Darby & Joan at Port Mapua. I found Nick to be extremely polite, amenable & willing to find a suitable solution & it was a pleasure working with him.

Because I was absent from MDCA's Monday night meeting I was not able to speak to this queries on the night. I had provided a full report & I am unsure why this even came into question.

I was interacting with Nick regarding the plaques placement & even though we were not able to achieve the options MDCA initially desired due to reasons explained in my report to MDCA, Nick very diplomatically found an alternative location close by.

One of the things I have learnt from being on the Mapua Waterfront Working Group is there are at least two TDC tenants at Port Mapua who are only interested in what they want and unfortunately they appear to always be able to call the shots with TDC's commercial dept. The personalities of the two tenants who have created most of the problems for community at the wharf over the years are not the easiest to work with

Being a landlord myself, I personally would not tolerate a tenant of mine dictating to me how things will be and it is a pity that TDC do not appear to stand firmer & enables them to impact community use of the wharf area. I even know that from time to time other businesses have issue with them as well.

I appreciate you being willing to follow issues up on behalf of MDCA, however, in this instance things were in hand.


