Following up on the question you asked regarding the potential for relooking at the anticipated Mapua Growth in a more holistic manner, the MDCA Exec is fully supportive of undertaking an updated Spatial Plan which would include not only housing, but also key greenspace/reserves, roading, parking, active transport and social services requirements, together with impacts of potential projects such as the Boat Ramp and additional Commercial Development in our area.
