Anna,

Good morning - I hope you are well and were not impacted by the severe weather over the past week.

On behalf of the MDCA attendees, a couple of follow-up questions / actions related to the initial stakeholder meeting we attended 3 weeks ago:

- We discussed a review of the 2010 Structure Plan to establish what progress had been made within our community over the past 12 years on any of the goals laid out in that document - is this being compiled and if so when will you be able to share?
- We discussed in general terms timeframes/deliverable for the Structure Plan Update and you shared the timeline as you see it via email last week. In terms of workscope/deliverable however, the group wants to ensure that the Update also addresses key issues that have emerged since, and hence were not part of, the original 2010 Structure Plan.
- With that in mind, we think it is important that the group meet again ahead on the planned Community Meeting scheduled for November (3 months away). If the Update simply covers the same scope as the 2010 version and does not address the key concerns of residents' related to land use, plan changes, etc, it will be hard to get the community onboard with the process and accepting of the outcomes.
- Finally, while we understand that the Update has a budget and that the timeline may be driven by other factors, conducting community consultation over the Xmas/New holiday period will be challenging. From the outset of this process it has always been the intention to hold multiple community meetings to ensure feedback is collected, incorporated and re-shared. With the first community meeting scheduled for November, then the Dec/Jan holidays period upon us, and a stated February deadline for completing the Update, when will the second community meeting be held?

The next MDCA Public Meeting is scheduled for 12th Sept, so if you could get back to me on this before then that would be much appreciated.
