the number of home these areas could support

There are multiple parcels of undeveloped residential land in Māpua, minimum allotment areas in the residential zone are 450m², this would be a basis for estimating the numbers of homes. The Future Development Strategy 2022 -2052 (Table 1) provides estimated numbers for the FDS areas.

■ how these potential new subdivisions will be connected to existing roading/pathway/reserve networks —

Indicative reserves, roads and walkways are mapped in the Tasman Resource Management Plan as part of the plan change process – these indicative items show where council would expect connections and open space. The final connections are determined through the consenting process.

• if/how TDC plan to prioritize current and future housing developments to ensure they enhance vs degrade existing connectivity and build on the establish retail/commercial centres.

As part of the plan change process to rezone land Indicative connections and open space (roads, walkways, reserves) are mapped and included in the Tasman Resource Management Plan. It is expected that these indicative items are provided when a resource consent application is made.

Community engagement sessions - please ensure that the community engagement sessions are fully minuted / documented, with the reasons why residents' feedback is adopted / not-adopted clearly explained - i.e. the same process as is used to consider/decide on Plan change submissions. This is critical to TDC credibility and building community awareness of and support for future changes.

The community engagement session scheduled for August/September (step 3) is a feedback session only, there will be no presentation or minutes taken. However, feedback will be summarised and provided to the community.

Step 5 – Public Engagement on the Options will be a facilitated session with outcomes summaries for the community.

Step 7 – is a formal process of decision making where there will be submissions, hearings and deliberations – this will be minuted/documented formally.

 Analysis of existing information including growth projections, technical information, infrastructure planning, council plans and documents and recent government direction.



Step 3: Community Engagement

 Early engagement on the masterplan principles, issues and opportunities.



Step 4: Development of draft options

 Development of draft options based on analysis and feedback



Step 5: Public Engagement – Consult on Draft Masterplan Options

 Seek community, iwi and stakeholders feedback on masterplan options



Step 6: Finalise Draft Masterplan and Circulate for Public Review

Analysis consultation feedback and develop a final draft masterplan



Step 7: Submissions, Hearings, Deliberations



Step 8: Council Decision on Masterplan
