Kia ora Colin,

I refer to your official information request dated 26 August 2023 for information relating to the Mapua Master Plan Steering Committee.

The information you have requested is below:

- **Can I please have a copy of the minutes of all the Mapua Master Plan Steering Committee meetings. If possible, I would like this before the community consultations planned for next Saturday.**

Council does not hold any formal minutes for the two steering committee meetings (rather, they were more workshops/briefings, not formal meetings).

We do, however hold a selection of drafted notes from the first meeting which is **attached**. Please note, the draft notes were never finalised and are just rough cut notes captured by the Service and Strategy EA during the meeting.

For context, we have also **attached** the materials that was discussed with the steering committee.

There are also no formal minutes recorded from the second meeting, only a general agreement among the members that the group can be disestablished, and governance returned to the Strategy & Policy committee.
