Re the AED funding and grants

If we have the funding, we could get in training for resuscitation by a certificated provider, as opposed to just the AED training that I can do and which costs us nothing. I suspect that, given that full resuscitation training is a time commitment of at least half a day, there might not be many takers, however I think it would be a good idea to approach the Business association and discuss with them about identifying the training needs of the businesses (i.e. staff) and seeing whether a combined training session might be useful. For instance the medical centre will have a clear training need as per their Cornerstone Quality program.
