4. Māpua Masterplan Steering Group Establishment

Discussion on group objective and future. Sharon Floods Masterplan 1-5yrs is complete. It didn't go into detail with regards to water, sewerage and roads. The group served a purpose with a diverse membership though numbers have reduced over time. Some services and community are not represented i.e. Emergency Services.

The only outstanding items from the plan are Grossi point works and a proposed playground, however location of the playground is not known.

The group feels there is value in meetings like these and the community like to talk about things and “make change for the good”, to “feel like they have a voice” and “are heard”.

Several options were offered for the future of the group. Continuing as a group outside of Council as it has been going for 15 years, joining the Community Association, , increasing community membership, or merging other groups. It was mentioned there are several ways to communicate with Council.

Some members felt staff weren't listening.
 The group was reminded about the Māpua area Drop-in sessions about to be held.
 Cr Kininmonth suggested a one-off meeting with key stakeholders.
 Grant will review the report to Council by the Strategy and Policy Team regarding the future form of the group.

5. General Business

Discussed the concrete on the beach. Iwi needs to be consulted to disturb ground. Nick advised iwi are opposed to any disturbance of Grossi Point. Mike believes consultation was undertaken 5 years ago for this in conjunction with Ngaio Park and Waterfront Park. Group would like to progress removal of surface concrete.

Discussion about rubbish fires lit on Bullivant Island, Cr Kininmonth to investigate options re. Damon Ward

Nick advised an additional camera was installed at the front of the building in the commercial area. Appleshed renovations are complete and WIFI is working well but can't cast onto screens.

The leak in Māpua Boat Club was resolved quickly.

The "Life ring" was tossed over the wharf, the Boat Club are donating another one. Camera will be checked for perpetrator.

The meeting closed with a karakia at 7.55pm.
