Last evening was the monthly meeting of the Mapua Community Association. I advised that the public consultation would start on the Masterplan on the 1st of November.

3 matters that I was asked to follow up on:

1. Can you confirm for me the length of the public submission process? **1 November to 16 February 2025**
2. How will the draft plan be notified to the community?
 - **Standard council channels eg: Newslines, facebook.**
 - **Information pamphlets will be delivered to all properties within the urban area of Māpua.**
 - **Individual letters will be sent to landowners with changes proposed on their land.**
 - **The MDCA will be provided with information on the submission process.**
3. When the draft plan is available, will the TDC also provide a link to all the supporting material that sits behind the masterplan?
The draft masterplan documents includes two documents; a draft masterplan and a draft masterplan supporting information document. Both of these documents will be available from the 1 November.
